Applications are invited on prescribed format for the project entitled "Development and Validation of Artificial Intelligence Tool for Screening/detection of Pulmonary TB and other lung diseases using Chest X-ray" for following post in the Department of Community Medicine Government Medical College, Ratlam (M.P.). Interested person with requisite qualification & experience may submit duly filled application with necessary documents comprising educational credentials in the office of Dean & CEO, Government Medical College, Ratlam (M.P) before ~~13/08/2022~~ between 09.00 am to 5.00 pm.

Shortlisted candidates will be informed by email in advance & will be required to appear in the interview. The applicants are advised to visit our website regularly for any updates.

The interview is scheduled to be held on ~~18/08/22~~ at 10.00 am in the office of Dr. Dhruvendra Pandey, Associate Professor, Department of Community Medicine, GMC Ratlam (M.P.)

1. Tenure: The assignments are purely on contract basis for the period specified above. **This appointment will not vest any right to claim by the candidate for regular appointment or permanent absorption in GMC Ratlam or ICMR or for continued contractual appointment.**
2. The last date of application submission would be used as the cut-off for calculation of age to consider eligibility.
3. Age relaxation: Age relaxation up to 5 years for retrenched government servants, departmental candidates (including project) and SC/ST/OBC candidates in accordance with the instructions issued by the central government. Age concession to the extent of service rendered in other research projects will also be admissible for experienced and skilled persons.
4. No TA/DA will be admissible for attending the interview.

6. Application Fees: Nil
7. Expiry of Contract: The contract will automatically expire on completion of period specified above until it is renewed with mutual consent for the decided period. The contractual appointment can be terminated at any time by either side by giving 30 day's notice or salary in lieu thereof. However, contract may be extended on yearly basis or till the project is completed, whichever is earlier, subject to performance evaluated by Project Principle investigator.
8. Accommodation: No hostel or any other accommodation will be provided by the institute/Principle investigator.
9. The candidate who is already in government service shall submit 'No Objection Certificate' from the present employer at the time of walk-in-written test or interview.

10. The prescribed qualification is a minimum and mere possessing the same does not entitle any candidate for selection.
11. The candidate should bring along original documents and certificates in support of his/her age, educational/professional qualification, experiences etc. two recent passport size color photographs. One set of self-attested photocopies of the relevant documents would need to be submitted with the application form. Failing these, he/she will not be allowed to participate in the walk-in-written or interview.
