- 2nd class PG degree + Ph. D degree in relevant subject (Microbiology/Virology/Biotechnology /Medical Microbiology /Genetic/Molecular biology) from a recognized university.

DESIRABLE QUALIFICATIONS: -

1. Knowledge of Computer Applications and Data Management
2. Track record of good publications related to virology/molecular work
3. Basic knowledge of accreditation of labs.

Note: -

1. Ph.D. degree in relevant subjects shall be treated equivalent to three years' experience after PG degree
2. Candidates with Ph.D. degree in relevant subject will be preferred for engagement.
3. Preference will be given to candidates having experience in molecular biology / virology related wet diagnostic laboratory /ELISA work/ research work in Government institute.

Terms and Conditions

1. The above-mentioned vacancy is for a fixed tenure of up to 31st March 2026.
2. Employment will automatically terminate upon completion tenure. Also, the candidates have no right to claim permanent employment based on this job.
