Subject: Essentiality Certificate- For increase in Seats of MBBS seats, 150 (30+EWS) to 250 for the Academic Session 2021-22.

The desired certificate is as follows:

- 1) It is certified that the Govt. Autonomous Medical College, Ratlam M.P. is Permitted U/S 10A of IMC Act 1956 for 150 (30+EWS) MBBS seats.
- 2) No. of institutions already existing in the State: 13 Government, 7 Private
- 3) No. of institutions offering MBBS course: 13 Government, 7 Private
- 4) No. of seats available in the MBBS course in the State: 3485
- 5) Full justification for increasing the intake of MBBS course: Madhya Pradesh is a large state of central India. The population of Madhya Pradesh as per 2011 census is 73.34 million. The doctor population ratio is below the national average. To cater and fulfill health needs of people of Madhya Pradesh there is need, for increase in the no. of Doctors hence increase in no. of MBBS seats is justified.

The Government autonomous Medical College, Ratlam has applied for increasing the annual intake of MBBS course to 250 seats. On careful consideration of the proposal, the Government of Madhya Pradesh has decided to issue an essentiality certificate to the applicant for increasing the annual intake in MBBS course to 250 seats.

- A)It is desirable to increase the annual intake in MBBS course from 150 (30+EWS) to 250 seats in the public interest.
- B)Increasing the annual intake in MBBS course from 150 (30+EWS) to 250 by Govt. autonomous Medical College, Ratlam is feasible.
- C) The institute has 600 beds (Attached District Hospital) and 750 beds (Newly Constructed Medical College Hospital) Total 1350 number of teaching beds.
- D)The average OPD strength per day is above 1800.

- E) The average bed occupancy is 90 %.
- F) The affiliated teaching hospital is unitary in character
- G) The number of teaching beds, average OPD strength and average bed occupancy available at Govt, autonomous Medical College, Ratlam is not less than the criteria prescribed under the "Opening of a Higher Course of Study or Training (including Postgraduate course of Study or Training) and increase of Admission Capacity in any course of Study or Training (including a Postgraduate Course of Study or Training) Regulation, 2000" as notified in the Gazette of India vide Notification dated 9th December, 2009.

It is further certified that in case the applicant fails to create infrastructure for the course as per NMC norms and fresh admissions are stopped by the Central Government, the State Government shall take over the responsibility of the students already admitted in the above said course at this college with permission of the Central Government.
