
1. The above-mentioned vacancy is for a fixed tenure of up to 6 months.

4. Leave: The nursing officer will be entitled for one day paid leave for every completed month of service & 1 weekly off will be given.
5. The absence from work for a period of fifteen days without proper permission of the competent authority will amount to voluntary abandonment of engagement and automatic termination
6. Accommodation: No hostel or any other accommodation will be provided by the Institute
7. No TA/DA will be paid for attending the interview/exam or for joining the post.
